Preparation of the collective monograph ‘*European and Euro-Atlantic Integration: Foreign Policy Aspects of 2014-2021*’:

Ukraine’s European and Euro-Atlantic integration is a strategic foreign policy priority of state policy. Important stages in Ukraine's integration progress were the period of implementation of the Partnership and Cooperation Agreement 1998-2008, as well as the roadmap for European integration progress - the Association Agreement between Ukraine and the EU. At the same time, various NATO-Ukraine plans were accumulating.

It is planned to summarize the active theoretical and practical work of Ukrainian scientists on the effectiveness of the country's European integration progress in 2014-2021 in the context of foreign policy aspects, including Ukraine's bilateral relations with the EU and NATO.
