(Uzhhorod, May 31, 2023)

The conference is included in the List of scientific conferences, formed by the Ministry of Education and Science of Ukraine in 2023 (letter of the Ministry of Education and Science of Ukraine dated 13.10.2022 No.21/08-3).

The conference will be held as part of the scientific project of UzhNU under the Erasmus + Program 'Jean Monnet Transcarpathian Center for Studying European Development Strategies at Uzhhorod National University' (Grant Agreement No.-619688-ERR-1-2020-1-UA-EPPJMO-CoE).

The event is devoted to highlighting the theoretical and practical results of the study of European development strategies. Scientists, teachers of higher educational institutions, doctoral students, post-graduate students, employees of state authorities and local self-government are invited to participate in the conference.

The representatives of partner institutions of higher education from EU member states, state authorities, local governments, civil society and business representatives will participate in the conference as international experts.

- Actual problems of foreign policy of the EU countries
- European policy of Ukraine: basic prerequisites, stages, problems and prospects of implementation
- University development strategies based on the principles of internationalization and sustainability policies

- Ukrainian dimension of European and Euro-Atlantic integration
- European experience of involving universities to increase the competitiveness of regions
- Improving the quality of European studies
- Immigration and transnationalism: the experience of the EU
- Migration as a factor of social transformations in the modern period of globalization and its impact on the situation in the EU countries
- European experience and value orientations of the population of the Carpathian region
- Information security in the countries of Central and Eastern Europe in the conditions of Russian aggression
- Institutional cooperation for the study of common cultural heritage
- Europeanization of the public administration system, formation of professional and personnel potential oriented towards European integration.

The materials of the Internet Conference will be published on the website <a href="http://eurodev.uzhnu.edu.ua/index.php/uk/anonsy-ta-novyny">http://eurodev.uzhnu.edu.ua/index.php/uk/anonsy-ta-novyny</a>. The collection of scientific works 'International Scientific Herald' will be published following the conference. The collection is presented in scientometric databases, repositories and search engines of the world, as well as on the platform 'Scientific Periodicals of

Ukraine'. DOI (Digital Object Identifier) will be appropriated to the scientific articles, which will be included in this collection.

The working languages of the conference are Ukrainian and English.

The form of participation is online or in absentia.

## **PUBLICATION REQUIREMENTS**

The articles appropriate for submission have to be original and not previously published and submitted to other publications (as well as electronic ones).

The order of placement of constituent elements in the article (from a paragraph, through an empty line):

- 1) UDC index (at the beginning on the left) typed 14 point Times New Roman, (in bold);
- 2) information about the author (on the right);
  - first name, last name and patronymic (in the nominative case);
    typed 14 point Times New Roman (italics in bold);
  - scientific degree, academic title, position and full name of the place of work, city, country (for foreign authors), contact telephone numbers and e-mail addresses; Times New Roman font, 14 point (italics in bold);
- 3) title of the article (in the center); Times New Roman font, 14 point (in large bold letters);
- **4) annotations:** *in Ukrainian and in English* in the form of an abstract, which should cover at least 1800 symbols with spaces (for both annotations, 1800 symbols Ukrainian annotation and 1800 symbols English).
- 5) **keywords** (from five to ten); font Times New Roman, 10 point (italics), width text align, paragraph indent 1.0 cm; keywords should not repeat the title of the article;
- 6) text of the article: 14 point Times New Roman, in 1.5 space; upper, lower, left and right edges 2 cm, width text align, paragraph indent 1.0 cm. Words are to be typed without hyphens. All non-text objects

are to be created by built-in Microsoft Word tools (objects must be grouped). Formulas are to be created using the Equation editor. Illustrations may be placed in the article's text, submitted in the form of files in TIFF, JPG, PCX format (with a resolution of at least 300 dpi), or on separate sheets. The recommended font size for text and table objects is 12 point Times New Roman.

7) **References** (at least 5 items) should be compiled following the standards of DSTU font Times New Roman, 14 point, text width, paragraph indent 1.0 cm. In the text of the link the used sources are indicated by numbers in square brackets according to the numbering in the list of used sources

## References should consist of two blocks:

**LIST OF USED SOURCES** - sources are submitted in the original language, prepared following the requirements specified above, and **REFERENCES** - a list of used sources, transliterated into the Latin alphabet and translated into English.

- 1. The symbols "//" and "-" should be removed from the transliterated text, replacing them with commas. English quotation marks ("") are used instead of traditional ones (« »).
- 2. Each transliterated title of the bibliographic reference should be typed in italics and expanded with an English translation (the title of the article, book, journal, conference, enclosed in square brackets and placed immediately after the transliterated title.
- 3. The place of publication is indicated in full (for example, "Kyiv," not "K.").
- 4. Information source (the indication of pages, volume, issue, number) is given in English, not transliterated (instead of «s.» should use «p.» or «pp.», for example, 12 p. or pp. 1-12), and instead of "t." (volume), "issue" (issue) and "№" (number) "vol.", "issue" and "no." correspondingly.
- 5. Roman numerals (for example, in conference titles) should be replaced by words or Arabic numerals (Second or 2nd instead of II).
- 6. Information on the type of publication is not indicated in the description of textbooks and manuals.
- 7. The description of the source indicates all the authors.
- 8. The year of publication is transferred to the beginning of the description, placed after the author's name in parentheses.

- 9. The date of access to information must be indicated when describing electronic sources.
- 10. All sources presented in *References* are arranged in the Latin alphabet. For example, 1. Cole M. Cultural Psychology... 2. Vygotskii L.S. Psikhologiia iskusstva ..., in contrast to the Ukrainian or Russian versions: 1. Vygotsky L.S. Psychology of art... 2. Cole M. Psychology of culture...

Materials are printed in the original language. The authors of the articles are responsible for the presented material. The editors reserve the right to edit the manuscript.
